High-level overview

Using HPE Project and Portfolio Management (PPM), Bausch + Lomb achieved the following benefits:

- Deploys single workflow process to standardize, automate, manage and capture the execution of operational activities across multiple enterprise groups with approximately 2,200 HPE PPM users
- Streamlines regulatory compliance: U.S.
 Food and Drug Administration (FDA)
 and Sarbanes-Oxley (SOX), with change management process ensuring governance rules are followed and documented
- Transforms management of Oracle PeopleSoft Human Capital Management (HCM), Financial and Supply Chain Management (FSCM), Enterprise Performance Management (EPM) and Customer Relationship Management (CRM) application platform in North America and Europe:
- Enables software change tracking: requirements, design, migration automation, test-execution signoff, release to production automated off hours

- Replaces Lotus Notes and other manual tools with repeatable automation—enabling headcount reductions and related cost savings, with improved quality
- Streamlines business processes: human resources, purchase requisitions (fed into Enterprise Resource Planning system), research and development

Business goals

Bausch + Lomb aimed to automate manual workflows, integrate disparate enterprise processes, reduce costs, streamline regulatory compliance and increase operational efficiency.

Fifteen years ago, Bausch + Lomb was an early adopter of the software that evolved into HPE PPM. It originally purchased the solution to automate processes related to Oracle PeopleSoft HCM and Financial Management. At the time, employees were using Lotus Notes as their database and manually copying code from one environment to another. In addition, various departments in Bausch + Lomb—finance, human resources, logistics, compliance, research and development and others—were following disparate processes and capturing different sets of information. The company wanted to standardize, automate, manage and capture the execution of operational activities.

Additional benefits

Enterprise groups throughout Bausch + Lomb have come to see that HPE PPM brings efficiencies and value to their business processes. HPE PPM enables users to capture information into the system, render it searchable and integrate with other systems. A 200-user group in Ireland, for example, leveraged HPE PPM to automate purchase requisitioning and then integrate it with the Enterprise Resource Planning system. These process efficiencies enabled them to reduce headcount by two contractors. In relation to FDA requirements, Bausch + Lomb must enact a change validation process every time it changes the formulation on an existing product, adds an additional manufacturing line, alters its packaging, and so on. HPE PPM streamlines this governance and validation process. HPE PPM is a workflow engine cascading throughout Bausch + Lomb enterprise groups to generate cost savings, create efficiencies and streamline compliance.
